TRADING

YOUR USDT WILL BE CREDITED WITHIN 10 TO 60 MINUTES. PLEASE NOTE THAT DEPOSITS ARE PROCESSED BETWEEN 10:00 AM AND 6:00 PM, MONDAY THROUGH SATURDAY.



WITHORAWAL PROCESS

TO WITHDRAW YOUR USDT, PLEASE ENSURE YOU MEET THE FOLLOWING REQUIREMENTS:

- 1. YOUR ACCOUNT MUST BE KYC VERIFIED.
- 2. YOU NEED TO ADD YOUR USDT POLYGON CHAIN ADDRESS IN THE ACCOUNT > ADDRESS SECTION.
- 3. YOU MUST HAVE AT LEAST 5 ACTIVE DIRECT REFERRALS.

ADDITIONALLY, THE FOLLOWING WITHDRAWAL CONDITIONS APPLY:

- 1. A 10% FEE WILL BE DEDUCTED AS WITHDRAWAL CHARGES.
- 2. THE WEEKLY WITHDRAWAL LIMIT IS 50 USDT PER USER.
